NEW SPECIES OF COMMENSAL COPEPOD

My research focuses on an undescribed species of commensal copepod found living in the shells of pagurid hermit crabs in southern California. This copepod falls within the Family Porcellidiidae, one of the 17 families of symbiotic harpacticoids. This copepod does not key to any known species or genus within the family (Huys 2016). This is also the first record of this family of copepods in California, where all other representatives from this group are distributed in the Indo-Pacific.

I have been working on this group of copepods since 2016. In previous years, I presented on the prevalence and intensity of this species as it relates to its hermit crab host. Over the course of three years, I collected hermit crab hosts during 13 sampling events at 14 different localities. Within these hosts, the population of copepods was highly localized along the Palos Verdes Peninsula localities. We also found that there is a strong significant relationship between this copepod and the presence of a limpet co-symbiont (Crepidula williamsi).

At present, I am currently focused on a formal description of the species. This effort was supported by a SCAS student grant award in 2022-2023 where the funds were used to purchase a microscope drawing tube. This

piece of equipment was vital to properly illustrate the fine anatomical details of the specimens. During the field collections of 2016-2019, I amassed thousands of specimens, which I kept in vials of 70% ethanol for long-term storage. These specimens were then cleared using lactic acid and stained using

lignin pink. Multiple illustrations of males and females, juveniles and adults, and habitus drawings were made. A draft manuscript is currently underway, and I expect to submit it for publication by Fall 2023. Completing these illustrations would not have been possible were it not for the generous support of the Southern California Academy of Sciences.

The Ocean Science Decade

Southern California is ocean country. From recreation to fisheries, offshore oil production and maritime commerce to a commencing burgeoning marine aquaculture, we are constantly reminded of

our dependence on and love for our local ocean. Ocean research is a substantial part of SCAS members' activities so we want to know what the <u>United</u>

Nations Decade of Ocean
Science for Sustainable
Development (2021-2030)
(unesco.org) can mean to SoCal and how can SoCal scientists participate.

The decade was declared by UNESCO (United Nations Education, Science and Cultural

Organization) in realization that ocean science must be further advanced to provide tools needed to sustainably develop ocean resources required to support the earth's population. The Decade's mantra is "The science we need for the ocean we want".

The ocean we want, according to UNESCO, includes the following six desires:

- A clean Ocean whereby sources of pollution are identified, quantified and reduced;
- A healthy and resilient Ocean whereby marine ecosystems are mapped and protected, and their services maintained;
- A predicted
 Ocean whereby society
 has the capacity to
 understand current and
 future ocean conditions,
 forecast their change
 and impact on human
 wellbeing and
 livelihoods;
- A safe Ocean whereby human communities are protected from ocean hazards and where safety of operations at sea and on the coast is ensured;
- A sustainably
 harvested and
 productive
 Ocean ensuring the
 provision of food supply
 and alternative
 livelihoods; and,
- A transparent and accessible
 Ocean whereby all nations, stakeholders and citizens have access to Ocean data and information, technologies, and have the capacities to inform their decisions.

To achieve these goals, research and development priorities are: 1) producing a comprehensive digital atlas of the ocean; 2) Developing a comprehensive ocean observing system for all major basins; 3) Achieving a quantitative understanding of ocean ecosystems and their functioning as the basis for their management and adaptation; 4) Providing a data and information portal; as well as 5) an integrated multi-hazard warning system; 6) Research and prediction for Ocean in earth-system observations, supported by social and human sciences and economic valuation; 7) Capacity-building and accelerated technology transfer, training and education with Ocean literacy; and finally, 8) Providing ocean science, data and information to inform policies for a well-functioning ocean in support of all sustainable development goals of for the year 2030. Paying for this research and development is not addressed but the utility of having goals and a research pathway stated to achieve them is a good start to earning the ocean we want.

Many of the goals are readily relevant to SoCal. Port pollution and DDT-dumping cleanup, fisheries management, climate change adaptation and hazard warning (Hurricane Hilary and other recent storms), and safety at sea (the Conception fire) are topics that are currently in the local news.

How could these goals influence research and science within the SoCal regions? Perhaps through the design of research programs, including the formatting and dissemination of data for the digital ocean as well as data portals, e.g., SCCOOS,

Notes from the Field: Seabed Station Launched

The Catalina Marine Society has launched its Jim Updike Seabed Station at Two Harbors, Santa Catalina Island. One of the requirements for the seabed station is that it supports non-magnetic cleats and attachment points for underwater sensors. Another is that divers can deploy sensors on it wearing typical SCUBA gloves, which often hamper a diver's dexterity. The station is essentially a concrete block with attachments of the appropriate materials and forms. It rests at a depth of 28.7 m (94 ft), 10 m from a mooring that occasionally becomes the Dirk Burcham Scientific Mooring. A line connects the base of the mooring to the seabed station, enabling divers to

quickly find the station when they descend the mooring chain.

The seabed station is intended to support instruments that would not operate properly on a moving chain, e.g., current meters and water level loggers, and which may include magnetic compasses. The initial sensor suite includes a vector current meter, a water-level logger and a pH logger. There are locations for additional instrumentation, which will be filled as sensor suites become available.

The Society's first research priority is to understand the relation between tides and currents at Two Harbors. Two Harbors has been a long-time site for oceanographic measurements of internal waves at Catalina, as well as many other studies conducted from the Wrigley Marine Science Center located nearby.

The Society invites other investigators to use the station if it supports their

Spotlight on Desert Research Institute
